## **Bourse Fee**

Bourse fees includes the following:

6' or 8' bourse table and a back up table, table cover, chairs, two showcases and a 3 day Las Vegas business license. If lamps and additional showcases are required, the additional fee is \$15 per case and \$10 per lamp rental.

## **CANCELLATIONS**

To cancel, a written cancellation must be received by the bourse chairperson prior to January 1st, 2012 to receive a full refund. Failure to do so will result in a forfeiture of your entire bourse fee.

## **SECURITY**

Security will be continuous from 2:00 p.m. Thursday until 4:00 p.m. Sunday. Carry over security will be the dealers' responsibility after that time.

## **RULES & REGULATIONS:**

- 1. Signs are permitted but are not to obstruct the view of other dealers. Exception to this is along the walls around the bourse room.**
- 2. To guarantee your same table for the next year's show, you must pay in full. A deposit will only guarantee a booth in the show. Dealers are not to sublet their table without approval of the bourse chairperson.**
- 3. Dealer badge changes must be done before January 20th. After January 20th a fee of \$25 per badge will apply.**
- 4. The LVNS chairperson has the right to deny bourse space to any dealer for what he/she deems just cause.**
- 5. The aforesaid show committee has the authority to eject any unruly person from the bourse room.**
- 6. The LVNS, its members and bourse chairpersons harmless for any loss by theft, disappearance, damage or any other contingency regarding dealer's materials.**
